OUTREACH PROGRAMS: IN 2021, WE DISTRIBUTED APPROXIMATELY 350K FREE BOOKS TO CLASSROOMS ALL OVER THE COUNTRY AND SENT SPEAKERS OVER VIDEO CHAT TO DOZENS OF CLASSROOMS TO ENGAGE STUDENTS DIRECTLY. WE HOSTED WEEKLY WEBINARS WITH OUR INTELLECTUAL TEAM CHOOSING TOPICS OF RELEVANCE TO MODERN TIMES AND THE WORKS OF AYN RAND. OUR BOOKS FOR TEACHERS PROGRAM INTRODUCED EBOOKS DISTRIBUTED THROUGH GOOGLE PLAY, SIGNIFICANTLY INCREASING THE REACH OF OUR EBOOK PROGRAM. WE POSTED 208 NEW VIDEOS TO OUR YOUTUBE CHANNEL, WHICH GREW TO ALMOST 77K SUBSCRIBERS. AMONG THE MANY NEW VIDEOS WERE NUMEROUS LECTURES FROM COURSES RANGING FROM HISTORY AND PHILOSOPHY TO ART AND CULTURAL ISSUES. OUR CHANNEL RECEIVED OVER 2.3 MILLION VIEWS TOTAL THIS YEAR, WITH THE MIKE WALLACE INTERVIEW OF AYN RAND RECEIVING 625K VIEWS. TWO MAJOR
