WE HOSTED WEEKLY WEBINARS WITH OUR INTELLECTUAL TEAM CHOOSING TOPICS OF RELEVANCE TO MODERN TIMES AND THE WORKS OF AYN RAND. OUR BOOKS FOR TEACHERS PROGRAM INTRODUCED EBOOKS DISTRIBUTED THROUGH GOOGLE PLAY, SIGNIFICANTLY INCREASING THE REACH OF OUR EBOOK PROGRAM.
