AMONG THE NEW VIDEOS WERE LECTURES, INTERVIEWS, AND PODCASTS ON TOPICS RANGING FROM HISTORY AND PHILOSOPHY TO CULTURAL ISSUES AND FOREIGN AFFAIRS. OUR CHANNEL VIEWS GREW SIGNIFICANTLY THIS FISCAL YEAR, WITH THE MIKE WALLACE INTERVIEW OF AYN RAND REACHING AN ALL-TIME TOTAL SURPASSING ONE MILLION VIEWS.
